**Explanation of Responses:**

1. This transaction involved the transfer of: (1) 8,464 shares from a Grantor Retained Annuity Trust managed by the Reporting Person to direct ownership by the Reporting Person's spouse; and (2) 14,292 shares from the Grantor Retained Annuity Trust to an LLC managed by the Reporting Person. The Reporting Person disclaims beneficial ownership of any shares held by the LLC.
2. The shares are held by West Summit Grand LLC, a limited liability company managed by the Reporting Person. The Reporting Person expressly disclaims beneficial ownership of the securities except to the extent of her pecuniary interest therein.
3. The shares are held by an LLC managed by the Reporting Person and owned by Trusts established for the benefit of the Reporting Person's children and the Reporting Person's spouse's children. The Reporting Person is the Trustee or Co-Trustee for each Trust.
