This Statement is filed on behalf of each of the following persons (collectively, the "Reporting Persons"):

- i) Tybourn Capital Management (HK) Limited ("Tybourn HK");
- ii) Tybourn Capital Management Limited ("Tybourn Cayman");
- iii) Tybourn Kesari Limited ("Tybourn Kesari"); and
- iv) Viswanathan Krishnan ("Mr. Krishnan")

This statement relates to securities held for the account of Tybourn Equity Master Fund ("Tybourn Master Fund"). Tybourn HK serves as the investment advisor to Tybourn Master Fund. Tybourn Cayman serves as the manager to Tybourn Master Fund and the parent of Tybourn HK. Tybourn Kesari is the parent of Tybourn Cayman. Mr. Krishnan is the principal and sole shareholder of Tybourn Kesari. In such capacities, Tybourn HK, Tybourn Cayman, Tybourn Kesari and Mr. Krishnan may be deemed to have voting and dispositive power over securities held for the Tybourn Master Fund. Each of the Reporting Persons disclaims beneficial ownership of such securities, except to the extent of its or his pecuniary interest therein.
